1. Meeting called to order at 9:25 a.m. by Stan Zoller.

Discussion of applicants for position of KEMPA Executive Director:

- Jacoby moved to appoint Linda Barrington KEMPA's Executive Director for a salary of \$3,000 and a travel budget of \$1,000. Should the board ask Barrington to do more than is listed on the job description, the board would provide an additional stipend. Willauer seconded. Motion passed.
- Barrington's comments:
 - She plans to keep track of what she does as Executive Director for the upcoming year, so the board has a better idea of what the position entails.
 - The board would like to put KEMPA Update online; it will not be mailed. Barrington will develop the newsletter as often as she and board feels one is necessary and more than likely at least four times a year.

Celebrations & Thank Yous:

- Barrington presented Johnson with his Certified Journalism Educator certificate.
- Zoller was recognized by Dow Jones as a Distinguished Adviser.
- Jan Kohls, former Executive Director, received JEA's Medal of Merit

Zoller: The scholastic journalism awards presented to KEMPA board members speak well of the organization. We should brag more.

• The board is sending thank you letters to Mike Doyle and Bill Murphy, who served on the KEMPA board but will no longer continue.

2. Secretary's Report/Approval of Minutes

- September Jacoby moved to approve the minutes as corrected (add Patrick Johnson's name under "New Business"). Prase seconded. Motion passed.
- October (correct spelling of Hank Koshollek's name under KEMPA Board of Directors).
- Minutes KEMPA minutes are emailed to board members and posted on the website. Currently, the minutes are password protected so only board members can view them online. Discussion: Should they be available to non-board members online, too? Juran moved to remove the password from the website to allow all KEMPA members to view minutes online; there will be a note on the website that the minutes are "to be approved." Johnson seconded. Motion passed.
- 3. Treasurer's Report
 - Barrington presented the KEMPA Financial Report.
 - She reformatted the report in hopes it is more transparent so we can see how much of each budget item we're spending.

- o Current balance: \$11,976.26
- There has been a \$1.35 discrepancy since February; Barrington met with the bank and it is no longer a problem.
- \circ Board approved report.
- 2010-2011 Budget
 - The membership projections were close. Eighty memberships were budgeted; 78 were actuals.
 - Twenty-six (correct on report from 27 to 26) mentees had free memberships as well as 4 board members.
 - Johnson will be refunded his membership fee. He does not advise a
 publication, but is like other board members who receive free
 membership because they do not advise publications yet contribute to
 KEMPA professionally (fall conference presenter). This will continue
 should he remain on the board in years to come.
 - o JEA Memberships/Rebates
 - JEA raised their membership from \$50 to \$55 as of July 1.
 - From now on, instead of being rebated by JEA for all JEA/KEMPA memberships, KEMPA will just keep \$5 of each membership fee.
 - No money came out of account to pay Jan Kohls for supplies.
 - We went about \$500 over the budgeted amount for gifts, donations.
 - Mentee membership overpayments: Advisers who became mentees but had already joined KEMPA were reimbursed for their membership. Barrington: From now on, if advisers have already paid for membership, they will receive their free membership the second year and not be reimbursed.
 - There is a \$2,105.70 surplus.
- 2011-2012 Proposed Budget
 - After all projections, budget is \$15,500 this year (after adjustments).
 - Projected expenses: \$15,400 (after adjustments).
 - o Jacoby moved to accept projected budget. Juran seconded. Motion passed.
 - Scholarships: The Gebhardt Award will be \$100 next year.
 - Executive Director: Change it to \$4,000. If necessary, additional money can be pulled from Fall Conference and Summer Workshop.
 - Expenses: Removed printing costs, Super-critiques (because paid by Fall Conference), overpayments for mentee memberships
 - Total expenses: \$15,400 \$650 over budget.
 - We will raise the day workshops in income from 3 to 4 workshops (\$2,100 to \$2,800) and, therefore, raise workshop expenses to \$1,200.
 - We also will raise memberships to 103.
 - Raise to \$15,400 we're now \$50 over budget.

 - Update on plaques: The first company messed up the plaques. Jacoby found another company to remake them, and they supposedly mailed the plaques out to the recipients. But, the recipients have not received them yet. Jacoby is going to look into this.
 - Johnson moved that KEMPA does not provide a thank you gift to Continuing Ed. Prase seconded. Motion passed.

 - o Program

Barrington has not heard from the other two recipients and has no way to contact them. Jan Kohls might have their information and will mail it to Barrington.
 - Alexandria's letter said she should receive \$800, not \$600, which is what the Board voted on. She will be receiving \$800.
 - KEMPA Update
 - The next one will come out the second or third week of March, to coordinate with Winter Advisers' Seminar
 - Convention Travel
 - The board approved Barrington's request to use her travel allowance to attend the CSPA convention in New York in March.
- 6. Membership Report
 - There 113 total members, compared to 106 last year; 21 are mentees, 6 are new members, 81 are renewal members, and 6 are professional members
 - Spring membership mailing
 - Mailing will include membership form, a copy of the Summer Workshop brochure, and a Day Camp flyer

 Willauer suggested adding a line for the publication's email address on the membership form; this will help KEMPA to keep in touch with publications should there be new advisers year to year

 - Zoller expressed concern about over-extending KEMPA, especially with two new tracks in Summer Workshop

3. Executive Director's Report

- Students have all received their scholarship money
- Gebhardt applications have been emailed, are available online, and are due June 15; Susan Tantillo has agreed to judge again
- Next *Update* will be in early April
- Only two students applied for scholarships this year; the deadline was March 23
- Barrington hopes to begin visiting member schools and took suggestions of schools from board members

4. Treasurer's Report - Willauer

- Be more aware of expenses; we have already spent half of what was budgeted

5. President's Report - Zoller

- Journalist of the Year
 - KEMPA needs to help JEA get more applicants; Barrington suggested including an announcement in *Update* and on KEMPAOnline.com
 - o Illinois only received four portfolios
- Chicago Public Schools
 - They do not permit teachers to attend professional development out of state; something to keep in mind for Fall Conference and Winter Seminar
 - We need to promote our Day Camp program to them

6. Membership Report - Praser

- Two mailings went out at the end of February: one to the 92 current members and one to 178 previous members
- 18 members have been received as of today: 2 are new mentees, 12 are renewals from last year, and 4 are returnees
- Praser is sending thank you letters and certificates
- Zoller also will be sending thank you notes

7. Old Business

a. Winter Seminar – Zoller & Praser

- Proposed schedule for 2013 includes break-out sessions in addition to featured speaker presentations, which might be more attractive to attendees based on survey data
- The net loss is approximately \$1,400, but Walworth did not donate the \$600 as usual, Jostens still is sending a check of \$500, and the remaining difference comes from covering the cost of the mentees
- We get 40 attendees for Winter Seminar all KEMPA members but send out 2,800 brochures. Emailing the brochure to members seems to be effective. Fewer printed brochures might be necessary in the future.
- Venue for 2013
 - Grand Geneva and Abbey are two practical options; both have agreed to keep food prices and room rates the same
 - Based on Hank Koshollek's comments, Barrington suggested getting a bid from Lake Lawn Resort, too
 - Zoller will check into Wisconsin Dells locations, including Kalahari and Wilderness Lodge
 - We need to sign on to a facility within the month

b. Day Workshops – Johnson, no report

c. Summer Workshop – Doyle

- Marketing efforts Zoller agreed to email members a pdf of brochure and post an announcement on Twitter. This is in addition to what Doyle already has completed to market the event
- Board agreed to allow commuter students to attend for a \$50 savings per student; this savings means the students will not have a room or eat breakfast; Doyle will look into securing a parent permission form for commuters
- d. Fall Conference Jacoby
 - The account was charged \$1,067 for items described as Winter Seminar; there should not have been any money pulled from that account for Winter Seminar; Jacoby will look into it.
 - Keep plaques, find a different vendor because of all of the problems with Sassy Shirts this year
 - \$721.87 deficit; it will roll over (or be forgotten possibly, according to Tracy in Continuing Ed.; Jacoby will look into it)
 - Recruitment of speakers
 - Johnson has begun to gather people from Marquette University for a strand on social and digital media; he already has commitments
 - Jacoby will email advisers and past speakers to return in May
 - Zoller contacted ChicagoNow about teaching a blogging session
 - Cook has some contacts, too

- 1. Call to Order: President Stan Zoller called the meeting to order at 9:40 a.m.
- 2. **Minutes:** Sandy moved acceptance of the minutes as printed. Tom Juran seconded. Minutes were approved.
- 3. **Executive Director:** Besides the printed report, Linda showed a flyer that the Texas Association of Journalism Educators (TAJE) had used to promote journalism to principals. She will prepare a KEMPA version of this to send to member schools' principals. Board members suggested it also appear in the next KEMPA Update and a copy should go in the adviser folders at Fall Conference. Sandy said she'd help with this.
- 4. **Treasurer:** The balance today is \$9,147.32. Jeff reminded us to use his gmail account instead of his school email account for KEMPA business.
- 5. President:
 - Jostens still hasn't paid the \$500 it had committed to last March's Winter Advisers Seminar. Jeff suggested sending them an invoice every day.

 - The recruiting of Literary Magazine advisers to join KEMPA was discussed at length. Sandy and Stan will each contact a lit. mag. adviser who is speaking at Fall Conference.
 - Stan said we are eager to form a partnership with Marquette, but Patrick reported that the timing is not good right now because of internal turmoil in the journalism department. That could change as the year goes on. When things improve he will let us know and contact them. Meanwhile, the board would like to pursue other possible partnerships: Stan will talk with John Kupetz at the College of Lake County and Kellie at Lake Forest College. Jill and Tom suggested WCTC, especially for its design and photo resources. Joe and Hank have a connection with WNPA. Linda suggested Madison Area Technical College. Patrick suggested we recruit students to join "j" the student branch of JEA. Kim said she'll make a "j" flyer for the Fall Conference folders.
- 6. **Membership:** Kim reported that we now have 90 members with more anticipated during the registration for Fall Conference. She had sent an email to those schools that sent students to Summer Workshop, inviting them to join KEMPA. Stan will send an email to all KEMPA members asking them to invite their Literary Magazine advisers to join KEMPA and come to Fall Conference. He will include a link to the Fall Conference brochure online. Tom suggested looking at the JEA membership list for Illinois and Wisconsin and invite non-KEMPA members to join.

7. Old Business:

Benet has provided no contact with an adviser so far; it will not run unless advisers are involved and present at the workshop.

- **Fall Conference:** Contracts have been mailed and Sandy encouraged board members to return their paperwork ASAP. Linda Barrington commended Sandy and Sandy K. for the excellent brochure and she commended Continuing Ed. For their swift mailing of the brochures. Sandy thanked Patrick in particular for finding Marquette staff to speak about digital media for the conference.
